GSCA updated on Maverick Street project

Last year the Gove Street Citizens Association (GSCA) voted 18 to 3 in favor of a complete historical rehab and condo project at the former DeAngelis Bakery building on the corner of Maverick and Orleans Streets.

Developers of the project at 173-177 Maverick MG2 will consolidate three buildings and create nine condo units and a commercial restaurant space on the ground floor.

However, residents in the area have been wondering when the rehab will occur.

At GSCA's July meeting attorney for the project, Richard Lynds, provided an update on the planned historic rehab.

"Since our approvals last year we have been going through a process with the Boston Planning and Development Agency on the design of this building," said Lynds. "Our goal all along has been to preserve the existing structure and the architectural elements that are on the building. We pretty much completed that part of the process. Since then we have been working with a structural engineer to determine whether or not we can preserve the building and modify it the way we proposed."

Lynds said the engineers will make the determination on whether or not the entire building will have to come down or if it can be preserved

Artist Andres Amador returns to Constitution Beach

San Francisco-based artist Andres Amador returned to Constitution Beach last Friday to turn the wet sand at low-tide into a temporary piece of visual art with the help of the community.

For the past six years, Save the Harbor/Save the Bay has brought Amador out for a day to take part in the non-profits Better Beaches Program that provides free events and programs on public beaches from Nahant to Nantasket.

On Friday afternoon Ama-

dor encouraged participants, who were mainly Save the Harbor/Save the Bay staffers, East Boston YMCA summer campers and some curious beach-goers, to join in the fun of creating his unique beach art. Residents of all ages had a blast for several hours at Eastie's only beach helping Amador

"Amador's extraordinary artwork can span over 100,000 square feet, which is achievable only during low tide, so his artworks do not last long - within minutes of finishing a piece, and often while still

in progress, the returning tide begins resetting the canvas," said Save the Harbor/Save the Bay's Bruce Berman.

Working with sand rakes and teams of volunteers, Amador created mandalas in the sand between the high- and low-tide lines that last for just a few hours on Constitution Beach. He had the help of Save the Harbor/Save the Bay's Youth Environmental Education program staff and 200 kids from the East Boston YMCA.

Madaro, Walsh testify on raising TNC fees

Last week, Rep. Adrian Madaro and Mayor Martin Walsh testified at the State House urging lawmakers to adopt legislation filed by Walsh and sponsored by Madaro that better aligns transportation network companies (TNCs), such as Uber and Lyft, with the East Boston's mobility goals.

"I was proud to advocate for two bills I filed (H1039 and H1041) to address ride-share-related congestion in East Boston and across the state," said Madaro. "These bills provide an incentive for shared rides and encourage public transportation by changing our TNC fee from a flat amount to a percentage-based model, including discounts for pooled rides and greater transparency on surge pricing."

In addition, one of the bills Madaro filed would levy a penalty on Uber and Lyft drivers coming or going to Logan Airport without a passenger, a

practice known as 'deadheading'.

"These deadhead trips added five million cars to Eastie streets last year," said Madaro. "These bills will cut down on the number of rideshares on our streets, decrease congestion, encourage public transit, and raise much needed revenue for road and transportation infrastructure."

House Bill H.1039 and H.1041, An Act Relative to Transportation Network Company Rider Assessments would charge passengers 6.25 percent of the total fare for single-occupancy trips and three percent of the total fare for shared trips. Half of the revenue would go to the city or town in which the miles were driven, and the other half would go to the Commonwealth Transportation Fund and MassDevelopment.

TNCs would also be charged a per-mile fee of 20 cents for all miles traveled with no passengers during

Crime is down 25 percent in Eastie so far this year

Reaching the halfway point in the year, East Boston has experienced a decrease in Part One Crime so far in 2019, according to statistics released by the Boston Police Department earlier this month.

According to statistics released by the Boston Police that compares Jan. 1, 2018 through July 21, 2018 with the same time period for 2019 overall Part One Crime is down 25 percent in Eastie.

There were 99 less Part One crimes reported when comparing the same period in 2018 with 2019. In total so far this year there have been only 292 Part One crimes compared to the 391 incidents that occurred between the same time frame in 2018.

In 2018 there were 130 larcenies reported, but that number has dropped to 100 so far this year.

Community Officer Dan Simons said there was also a huge decrease in robbery and

attempted robberies. In 2018 there were 54 reports of robbery and attempted robberies. That number has dropped to just 26 this year.

Residential burglaries also dropped with 39 occurring in 2018 and 28 occurring so far this year.

Larceny from a motor vehicle has also dropped from 58 incidents in the same time period in 2018 to 47 in 2019 and auto theft dropped from 23 to 20.

However, domestic aggravated assault has increased from 22 to 25 while non-domestic aggravated assault dropped from 49 to 23.

Rape or attempted rape dropped so far this year when compared to 2018 with 12 incidents last year compared to six this year.

However, commercial burglaries rose from 3 to 16 when comparing the same time period in 2018 to 2019.

Success on the Diamond

Steven Walsh records his 300th hit in Yawkey League

Steven Walsh is in his 18th season in the Yawkey League, a longtime association with the semi-pro baseball league that started after his graduation from East Boston High School.

Walsh is still doing what he did best for EBHS coaches Donnie DiLorenzo and Phil Brangiforte in his three-year All-Star career as a Jet: hitting the ball exceptionally well and helping his team win.

Walsh, now 37 and playing for the Brighton Braves, celebrated an impressive milestone in a July 25 Yawkey League game against the McKay Club at Rogers Park in Brighton. The 6-foot, right-handed batter produced the 300th hit of his Yawkey League career. For the record, Walsh adroitly placed a hard-hit grounder between the third baseman and shortstop for a single. McKay Club Manager and league President Emeritus Dave McKay presented Walsh with the game ball while players on both teams applauded.

The moment was particularly emotional for Walsh, who wasn't sure he'd be able to continue his baseball career following a devastating knee injury that he sustained in a skiing accident six years ago.

"I missed the entire 2013 season because of the skiing accident," said Walsh. "I had to have surgery to repair three ligaments (ACL, MCL, and

LCL)."

After several months of rehabilitation, he was able to return for the 2014 campaign.

His love of the game was built early on

Walsh was introduced to baseball in the East Boston Little League where his talent was recognized early. He was an All-Star in the Minor and Major Division, playing two years for the Williamsport team.

His father, Paul, was a strong source of support from the beginning.

"My father has been at virtually every one of my games for my whole life," said Steven appreciatively.

Steven made his varsity baseball debut as a sophomore at East Boston High School and later played American League baseball and one season of collegiate baseball at Salem State.

"I was coached by Donnie DiLorenzo for my first two seasons in high school and Phil Brangiforte (the current EBHS principal) was my coach in my senior year," said Walsh, who was an All-Star outfielder and a .300 hitter. "My coaches were awesome. They made the game fun and I learned so much from them."

Looking to play baseball at a highly competitive level in the summertime, Walsh began playing in the Yawkey League, an elite loop that has current college players and former professional players.

He played his first two sea-

sons with the Boston Padres before joining the East Boston Blue Sox and eventually the East Boston Bombers who were coached by Ron Jordan. He played for the Harbor Point (Dorchester) Dodgers and became a member of the Brighton Braves in 2014.

"Interestingly, I have two career Yawkey League home runs and they came one week apart for the East Boston Blue Sox in 2004," recalled Walsh, a four-time Yawkey League All-Star and Gold Glove award recipient.

Also highly regarded for his defensive skills in the outfield, Walsh said he patterns his game after Dwight Evans, his boyhood idol who was known for his cannon arm and prolific bat.

"My favorite ballplayer growing up was [former Red Sox star] Dwight Evans," said Walsh.

On the road to reaching the 300-hit milestone, Walsh said he has batted against some truly terrific pitchers. He lists four hurlers in the "toughest I have faced" category: Mike Smith, former Toronto Blue Jays pitcher and now a Yawkey League teammate; former Providence College pitcher Marc DesRoches of the Somerville Alibrandis; Derek Bates of the Somerville Alibrandis; and now-teammate Mike McCarthy of the Revere Rockies.

Outstanding Sandlot Athlete Award in 2019

Steven Walsh was the re-

cipient of the 2019 Outstanding Sandlot Athlete of the Year Award at the annual East Boston Athletic Board Banquet in June.

It was a full-circle achievement for the lifelong baseball standout who was named the Outstanding Baseball Athlete of the Year by the same organization in 1999.

From his earliest days on the fields of the East Boston Little League until today where he continues to put on the uniform and compete, Steve Walsh has been an ambassador of the game, always encouraging young athletes to play baseball.

He knows the end may be near as an active player and he's okay with that. "After two knee surgeries, it's tough playing alongside the college players – they call me, 'Uncle Walshy,'" he said with a smile.

But asked specifically if this season might be his last, Steve Walsh replied, "I'll continue to play ball for as long as I can or my body allows me. I love the quote from George Bernard Shaw who said, 'We don't stop playing because we grow old, we grow old because we stop playing.'"

"With that being said, I hope to stay young and continue to play."

It's safe to say that Steve Walsh will back on the field in 2020 and for many years to come collecting additional base hits and memories.

Friends and family pay tribute to Eastie's Joe Harvard at the Middle East

In the 1980s an East Boston guy had an idea to create a Boston recording studio that would authentically capture the emerging alternative Boston music scene. Fort Apache in Roxbury was born and artists like The Pixies, The Lemonheads, Dinosaur Jr., Morphine, Buffalo Tom, The Mighty Mighty Bosstones were given the freedom to experiment and capture the energy of music without sterilization.

Harvard, an accomplished musician, music producer, artist and all around great soul passed away on Sunday, March 24, after a courageous battle with cancer. He was 60 years old.

On Sunday, friends and family gathered at the Middle East in Cambridge, the spot that launched many local acts that Harvard recorded at his studio, to pay tribute to Harvard.

There was only one way to truly honor a man who loved music and who was to bring the house down with numerous energetic performances by

Harvard's friends and former bandmates over the course of several hours.

"Tonight was just perfect," said Harvard's longtime partner Mallory Messara. "I know Joe was there, loving the sh@# out of every moment. Everyone who came, far and wide I can't thank you enough, as well as everyone who couldn't come but sent their love. It was truly beautiful for such a beautiful man. A life well lived indeed."

Harvard, who was born in Jeffries Point as Joe Incagnoli, had been living in Asbury Park, NJ since 2001 where he emerged as a leading force in the town's art and music scene renaissance.

"What an epic night," said friend and bandmate Stevan Nix who played at the tribute party. "I was absolutely elated. I made some great new friends and also heard some of the most fantastic stories about Joe Harvard that I can't believe I didn't already know. I would love for this to become an annual event. Over the course of the night it became quite obvious that Joe packed way more than a lot of living in his 60 years.

I was certainly anticipating a good sized crowd, but I could not believe how many people actually came out to celebrate Joe's life, what a beautiful thing. Everyone was so great. I'm so glad we were there to represent for Joe and in some way I got to repay a bit of all the things he taught me, playing in this great band with him for the last 10 years. Wow what a night."

Harvard was diagnosed with Stage 4 liver cancer late last year and documented his daily struggle with the disease through honest, and sometimes heart-wrenching, social media posts.

All the while Harvard remained optimistic and continued his art and music until the end, and telling friends back in Eastie he was fighting the disease like an, "East Boston tornado!"

Harvard was born and raised in Eastie and attended schools here. In a short YouTube documentary about his life produced by Messara Harvard drove around his old stomping grounds in Jeffries Point, pointed out the bar where he shined shoes while his father held court inside, and vis-

ited his childhood home.

Harvard graduated from Harvard University and the Ivy Leaguer got the 'Harvard' nickname while working in a Cambridge record store while attending college.

In 1986, with fellow Ivy Leaguers and friends Sean Slade, Jim Fitting and Paul Kolderie, Harvard founded Fort Apache Studio in Roxbury.

If you ate, slept and breathed the alternative music scene during that time you knew of and respected Fort Apache for the enormous talent it recorded for over a decade.

Harvard briefly became sole owner, and the studio became very active recording Boston-area indie-rock groups.

"I was honored to be asked to perform as Nico from the Velvet Underground band for Joe Harvard's Memorial," said friend Theresia Millasovich. "Joe had a cover band called 'Velveeta.' I sang 'To All Tomorrow's Parties'. No rehearsal....just do it....the Joe Harvard way. I love you, Joe."

Simons pointed out that the commercial breaks sometimes spike especially when there is one suspect hitting numerous businesses.

For example, one thief is on the loose and responsible for several break-ins at popular restaurants in Orient Heights Square.

The thief first struck on July 1 at night long after Orient Heights Square restaurants and bars are closed. The suspect broke into Renegades on Bennington Street and later hit Luna Restaurant on Saratoga Street across from Noyes

Field.

The suspect returned on July 5 and hit Renegades for a second time.

“Our detectives are working on this case and have good video of the suspect and identified him as a person of interest,” said District A-7 Community Officer Dan Simons.

Simons said that the suspect is described as a white male driving a dark-colored pick-up truck.

Simons said community members wishing to assist this investigation anonymously can do so by calling the

CrimeStoppers Tip Line at 1 (800) 494-TIPS or by texting the word ‘TIP’ to CRIME (27463). The Boston Police Department will stringently guard and protect the identities of all those who wish to help this investigation in an anonymous manner.

Simons added that crime in Eastie has been on a downward spiral since 2009.

Ten years ago Eastie had 1,322 incidents of Part One Crimes and in 2018 that number dropped dramatically and the total was only 658 total Part One crimes.

and rehabbed in its current state.

“Hopefully we will have that determination in the next four to six weeks,” said Lynds.

Lynds said if it is recommended that the entire building come down his client will have to go through the Article 85 process to ensure any building that is over 50 years goes through a review by the city to determine if it is historically significant.

If the building has to be razed Lynds said he will most likely come back before the GSCA for a further community process and discuss next steps.

Lynds said regardless if the building is preserved or demolished the final product will look exactly the same as renderings approved by the

BPDA and Zoning Board of Appeals.

“Nothing about the project changes if it has to come down,” he said.

Currently there are six units in the three buildings. While the developer will be going from six units to nine units the project will reduce the current bedroom count from 18 bedroom to 14 bedrooms.

The project will be a mix of studio, one- and two-bedroom units.

The proposed project will also add a fourth floor to the building that will be set back and make use of more modern materials.

Lynds said MG2 is currently in negotiations with a local restaurant to occupy the 2,250 sq. ft. commercial space on the ground floor.

While he would not name the restaurant, Lynds said it was an Eastie-based business that was looking to expand and thought the space would be a perfect fit for them and the area.

he planned as a way to honor him and his last wishes.

“Recently, we were contacted by the Food Network to let us know about a very special person,” said Italian Express’s Jonathan Harker. “Harris Halperin, a huge fan of Guy Fieri and Triple D’s passed away a few months ago from a rare form of lymphoma cancer. He was very passionate about food and making these plans gave both him and his family hope during this very difficult time. He was very active in high school and loved by many in his Ardsley, New York community and surrounding areas.”

Last Thursday Harris’s parents Jennifer and Dave went to Itaian Express with their friends to have the meal Harris had planned for himself and his family. Harris’s brother Matthew was at summer camp and did not attend, but called the family on video chat during the meal.

“Before the family arrived, we set up the table with blue and yellow flowers and balloons, which are the high-school colors that Harris attended,” said Harker.

In addition to the decorations Italian Express owners Harker and Jim Iannuzzi left a seat empty and reserved for Harris next to his mother.

“We brought out the Frutti Di Mare that he planned on having had he been there as an additional gesture to honor him,” said Harker. “We poured all of the love, light and kindness we could into making sure his parents and their friends had a memorable and restorative experience.”

Harker said cancer hits very close to home because Iannuzzi is a cancer survivor.

“We have met countless people battling this horrible disease and lost both family members and friends,” said Harker. “During the course of the evening, many tears were shed and stories exchanged. It’s difficult to put into words exactly what transpired, but our intention is that this story will give people hope that life goes on and also there is still so much love and support out there. Food has a way of bringing people together and can help heal our wounds and conditions.”

Harker said Italian Express

has a sign that hangs over its front door that says, “Enter as strangers, leave as friends.”

“That is what happened last Thursday night with the Halperin family and so much more,” said Harker. “Harris did not waste a second of his life and made plans up until the very end. Much can be learned from his life about being fully present and not taking anything for granted. We are inspired by his bravery and it was a blessing to be part of the Halperin family’s journey.”

peak hours. Half of the revenue would go to the city or town in which the miles were driven, and the other half would go to the Commonwealth Transportation Fund and MassDevelopment.

“Transportation network companies have changed the way people travel,” said Walsh at the hearing. “In some ways, they’ve made things more convenient. But they’ve also increased congestion, especially during rush hour. And they’re adding to the emissions that harm air quality and cause climate change. We have to find ways to make rideshares part of a sustainable and equitable transportation system. This bill would help us do that. This legislation would improve upon the TNC regulations already in place. It would adjust the assessment to better reflect and mitigate the impact on our streets and our environment.”

Walsh said right now, 20 cents per ride is collected and split between cities and towns, MassDevelopment, and the Commonwealth Transportation Fund. Last year, the City of Boston took in \$3.4 million from TNC assessments.

“We are re-investing this money directly into things that make our entire transportation system better, whether

you walk, bike, drive, take the T, or use ride shares,” said Walsh. “This is a good start. But honestly, it doesn’t go far enough.”

Madaro testified that approximately 81.3 million TNC rides originated in the state in 2018 with 15 percent of that total traveling through Eastie.

“Out of that number 12 million of TNC rides, almost 15 percent of state total, travelled through my district, going to and from Logan Airport,” said Madaro. “Five million of which were deadhead rides - meaning they went to Logan or left Logan empty. An increase in congestion has created gridlock on our neigh-

borhood streets and clogged the two Boston Harbor tunnels which are the connection to the city for our neighborhood, and many in North Shore. Today in the morning, we cannot move around the neighborhood. The increased congestion has impacted quality of life for residents across the area.”

Madaro added that while TNCs are a convenient mode of transportation for many, “We need to make sure that they pay their fair share and help address the impacts their operations have on our roads and communities.”

GOV. BAKER'S BOLD TRANSPORTATION PROPOSAL

We were talking the other day with a young man who has been a teacher at Chelsea High School for the past couple of years. During our discussion, we were surprised to learn that he lives on the South Shore (Hull) from where he commutes to Chelsea High every day by means of public transportation.

He takes the MBTA commuter boat to Boston and then walks to the nearby Blue Line, taking that to Airport Station. From there, he gets on the new Silver Line 3, the dedicated-lane bus line that takes him to Chelsea.

It seemed like quite an odyssey -- and it certainly is -- but he said his total commuting time is about an hour each way, which is less time than it would take him to drive it, not to mention far less stressful.

We were thinking about the Chelsea teacher's use of multiple modes of public transportation -- sort of an alternative, real-life version of the comedy classic movie *Planes, Trains, and Automobiles* -- in the context of the \$18 billion proposal put forward last week by the administration of Gov. Charlie Baker and Lieut. Gov. Karen Polito to improve the transportation infrastructure in our state, with the stated goals of improving our roads, bridges, and public transit systems.

We do not even remotely pretend to be experts in the realm of transportation. However, what is clear is that the Baker-Polito proposal, in terms of the level and scope of the proposed investment, is (in Baker's words), "unprecedented and historic."

We have no doubt that there will be many -- who actually are experts in the realm of transportation -- who will weigh in with various proposals of their own in addition to those that are contained in the Baker-Polito bill.

We also have no doubt that the plans and ideas that will be put forward by others will be considered carefully by the governor and his staff. After five years of the Baker-Polito administration, it has become clear that their type of leadership is not of the "my way or the highway" (no pun intended) style. We anticipate that the administration and the legislature will work together to craft a bill that will improve the daily lives for all residents of the Commonwealth.

For far too long, transportation issues have been like that adage about the weather: Everybody talks about it, but nobody does anything about it. In New York City for example, the sorry state of the subways is at a critical point -- and yet the mayor and governor cannot agree on a way to fix it. In California, talk of a high-speed train from San Francisco to Los Angeles appears to have reached a dead end (again, no pun intended).

By contrast, the \$18 billion proposal put forward by the Baker-Polito administration last week represents a huge step forward in fixing many of the problems that have come to light in recent years in our state.

Investments in our transportation infrastructure -- especially in this era of low interest rates -- will reap huge dividends in the years ahead, more than offsetting the costs. We look forward to the final transportation bill and to the day when Massachusetts will be seen as a national leader in solving public transportation issues.

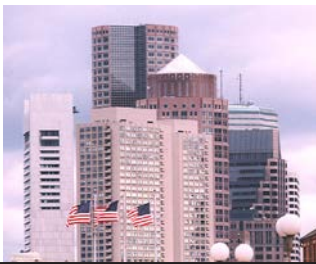

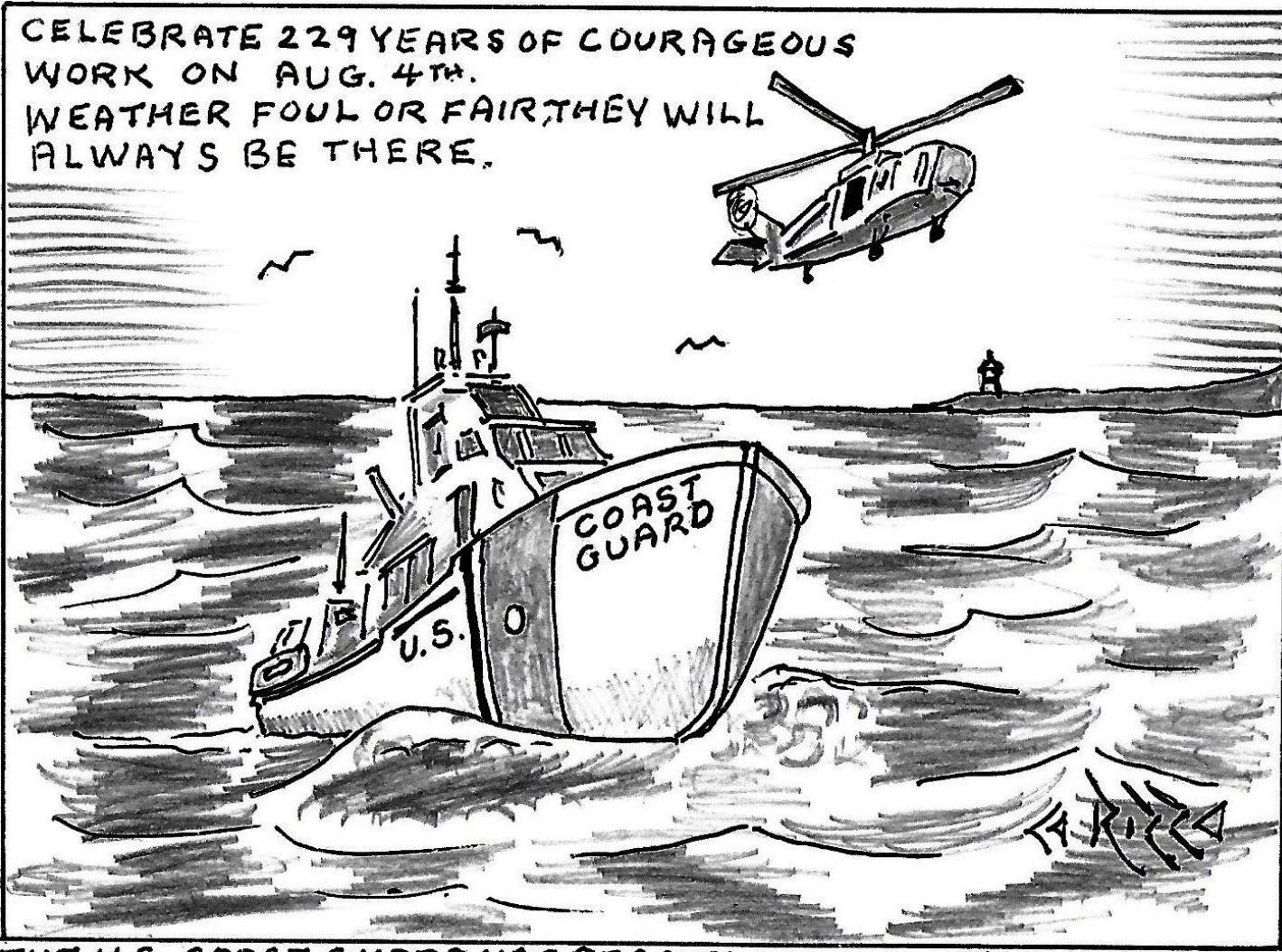

Armed with dozens of printed-out sketches, Amador hands participants a rake, and a sketch and has them get to work alongside him to create a magnificent work of art that only last a few hours.

After providing sand rakes to all participants and explaining some basic techniques, residents of all ages got to work in helping Amador create this large scale natural art on the sand.

Amador has called his art Playa Paintings and began doing these works around the country since 2004.

“The idea came to me while studying geometry, ancient architecture and crop circles,” he said. “Our ancestors created their magnificent works with very simple tools, but armed with great geometric insights. From there the art has evolved into many different styles over the years a medium guides the exploration.”

Amador generally gives himself about two hours to work. However, as more people join in and help him he can do larger or more ambitious works. But everything must happen during the low-tide, and ideally during the window in which the tide is at its lowest.

Amador said he does this type of art because it gets him out to the beach and in the fresh air to experience the elements of sun or wind or rain.

“I do it because it brings me peace and focus,” he said. “Ultimately, I do it because of the joy of the challenge. The art form feels to me to be an exploration of the various ways to make large-scale creations. Over the years I have found a number of methods, and new ones continue to present themselves as I explore deeper. This year I purchased a copter with camera attached so that I can make the art and take photos at the landscape level in locations never before available to me. That has opened up whole new avenues of exploration. So I suppose I do it because the art form continues to delight me with possibilities. And truly, it’s always a good day at the beach.”

Amador has been featured on the BBC, CNN, Discovery Channel, and numerous TV programs and periodicals globally.

Getting Out

Gloucester Stage Company's farcical 'The 39 Steps' closes its sold-out, three-week run

Gloucester Stage Company's hilarious production of Scottish writer Patrick Barlow's farcical poke at noir mystery plays produced a reaction I rarely experience.

Kudos to Artistic Director/Director Robert Walsh, cast and crew. At last Saturday's matinee of "The 39 Steps," theatergoers and I laughed out loud frequently, mostly because of the cast's stellar, outrageously zany, slapstick shenanigans.

Walsh gathered an ensemble of Boston-area's finest, award-winning actors, whose impeccable timing, wackiness, rapid character and costume changes (kudos designer Miranda Kau Giurleo), accompanied by Russ Swift's lighting, David Wilson's bat-

tery of sounds, Emma Sharp's clever simplicity with props, Jenna McFarland Lord's minimalist set and overall stage

effects earned standing ovations from sold-out crowds.

Surrounded by theatergoers on three sides, actors Paul

Melendy, Gabriel Kuttner, Lewis D. Wheeler, Amanda Collins and Malachi Rosen (enhancing sound effects), obviously were having a great time, as Melendy and Kuttner frequently ad-libbed, making their co-actors and audiences giggle.

The plot takes second place to the cast's wild wackiness, especially Melendy and Kuttner portraying clowns - without the clown makeup and garb - and other cameo roles.

Loosely adapted from John Buchan's 1915 novel, "The 39 Steps," and the 1935 British mystery thriller movie directed by Alfred Hitchcock, master of the unexpected and ironic, the two-act, 100-minute play focuses on Richard Hannay, (dryly portrayed by Wheeler), a civilian in London who

innocently becomes involved with Annabella Smith (terrific stunts by Collins), a beautiful attractive, counter-espionage agent, whom Hannay is accused of murdering. He escapes to Scotland to find himself suddenly involved in trying to prevent an espionage organization named the 39 Steps from stealing British military secrets.

"The 39 Steps" has been performed in more than 40 countries, garnering major awards.

Based on theatergoers and critics' enthusiastic responses, I'd wager Gloucester Stage Company's production rivals outstanding productions anywhere.

If you saw this production of "The 39 Steps," lucky you. If you missed it, you may want to see Richard Strand's

play, "Ben Butler," appearing August 2-25, Wednesday-Saturday, at 7:30 p.m., also matinees Saturday and Sunday at 2 p.m. at Gloucester Stage. It's the story of the little-known political leader-Union general-activist and his inner struggle on whether they should harbor or return a runaway slave during the Civil War. 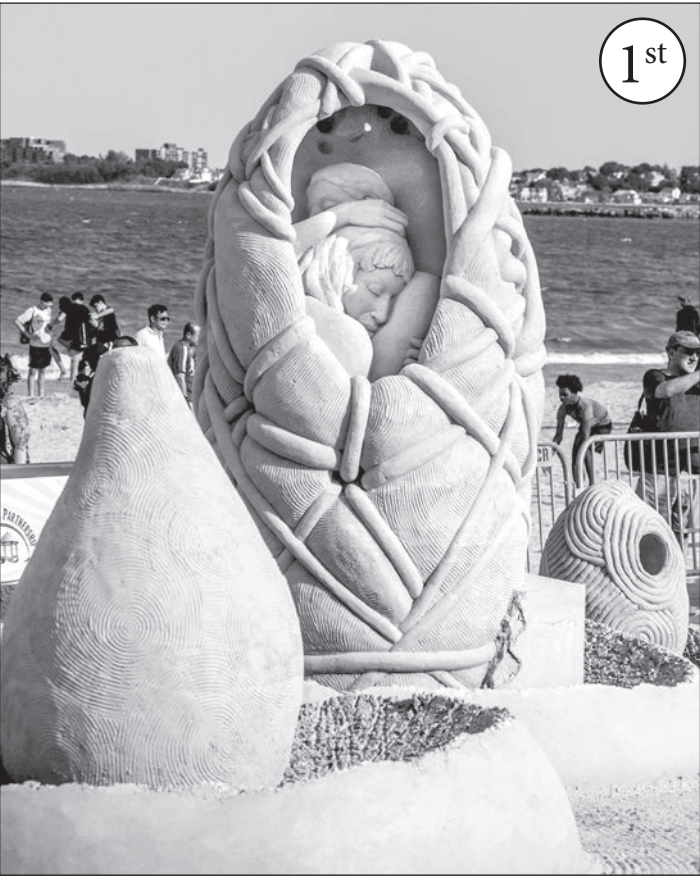

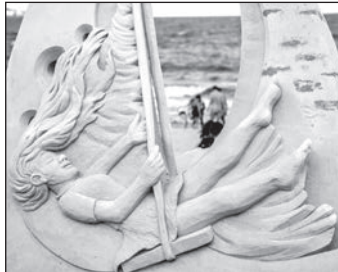

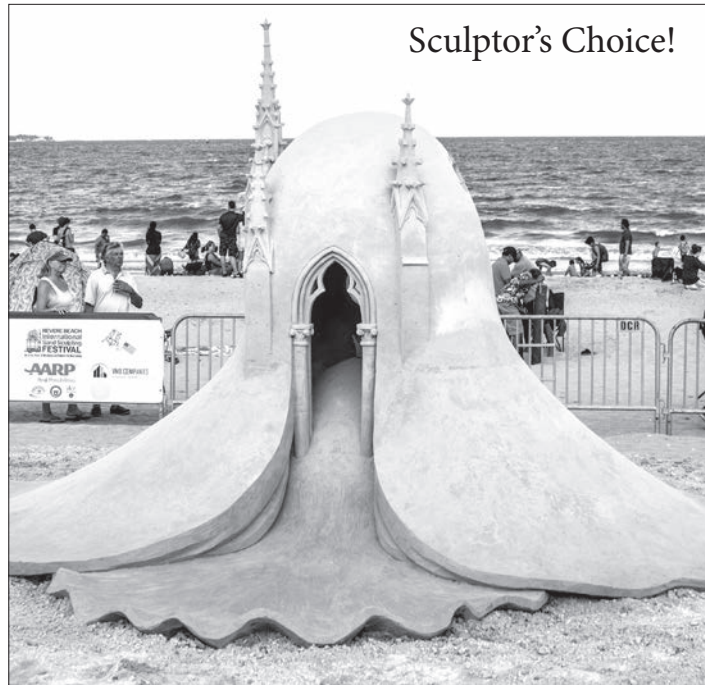

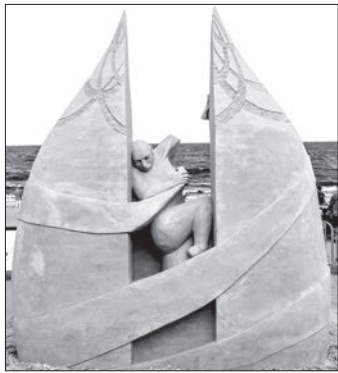
